

“Gameloft Christmas” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. INTERNET ACCESS AND VALID E-MAIL ACCOUNT NECESSARY TO PARTICIPATE.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Gameloft Christmas” Sweepstakes ("Sweepstakes") will begin at 3:00 pm GMT time on December 15th, 2011 and end at 3:00 pm GMT on January 2nd, 2012 ("Sweepstakes Period"). To Enter: Become a fan of Gameloft’s profile on Facebook.com at <http://www.facebook.com/gameloft>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to <http://www.facebook.com/gameloft>, and become a fan of this profile. Once you’re a fan of Gameloft, you can enter to Gameloft Christmas Sweepstakes by creating your wish list according to the gift categories provided on the Sweepstakes Tab. Entrants will have to create its wish list by choosing one gift in each of the six gift category and provide its name and e-mail address.

You can invite your friends on Facebook to enter this Sweepstakes. Each entrant may submit only one entry during the Sweepstakes Period.
